The process is very straightforward and comprises of three main steps:



Register your details



Upload copies of the required document



Sign an authorization letter

Once your verification has been processed you will receive your report, and another copy will be shared with Healthmark to review your Application.

Single Document USD 90	Primary Source Verification Verification (PSV) any one of the following: Highest educational qualification; or Professional license or membership; or Experience certificate issued by previous employer; or Good standing certificate from your previous professions regulator or employer	Clear scanned copies of: Passport; and One Academic Certificate; or One Previous Experience Certificate; or One Professional license or membership; or One Certificate of Good Standing
Report Transfer USD 55	Transferring a candidate's DataFlow report issued previously to another Ministry or Authority, to Healthmark's Platform, provided that the report does not include new documents.	Clear scanned copies of: Passport; andPrevious DataFlow Report or Report Reference Number.

Note: The Issuing Authorities may seek specific additional documents and/or information required for verification. An Associate from the DataFlow Group team will be in contact for any supplementary requirements.

A Step-By-Step Application Guide

To apply for your Primary Source Verification for Healthmark, simply click here or scan the QR code.





Fill the Application Registration
Form and select 'Healthmark' from the
dropdown menu



Once you submit the form, you will receive an email containing an activation link



Activate your account, then enter your registered email ID and password



Click on the 'Detailed Case Entry' button to initiate your application



Provide all information and documents listed on the following pages:

- Personal Details
- Education
- Employment
- Professional License or Membership
- Certificate of Good Standing



After entering all component details and uploading the required documents - digitally sign the Letter of Authorization



Carefully review your details before submitting your application

*To edit, click on the 'Edit' tab



On the 'Payment' page, view the overall fee and click 'Submit Application' to proceed to the payment gateway



Once the payment is finalized, the system will automatically populate a printable payment receipt and forward your case to initiate the verification process

You can track the status of your application at any time - simply click on the 'Check Your Status' button
